Governor's Report.

I attended the SW Region Governor's meeting that was hosted in conjunction with Cowtown Vettes First Choice weekend September 19th & 20th at the Texas Motor Speedway. The governor's meeting was held at 8:00 PM at the Hampton Inn Host hotel located at Alliance Airport on I-35 North. All of the SW Region governors were in attendance, except for two governors. All governors in attendance submitted First Choice Weekend requests, and there were no requests for the identical weekends. I submitted a First Choice weekend request for May 22nd & 23 for 7 autocrosses at the Mineral Wells airport, in conjunction with 4 Brazos River Corvette Club (BRCC) autocrosses, like we did this past June 2009. The Oklahoma City Corvette Club (OCCC) will host the 2009 awards banquet in the spring of 2010. The date and location will be announced later. I talked with Scott Wheeler about CCT teaming with CTV to host the 2010 awards banquet, with the location being at TMS Condo club house, where we have our CCT annual holiday party each December. Just a reminder, our annual party will be December 19th at the TMS condo club house and Ronnie Walker will be providing the music, as he has done previously in the past. THANKS to RONNIE, his wife and brother & sister-in-law for helping Ronnie set up and take down all the sound equipment required for the entertainment.

Your 2010 NCCC membership dues are due at our October 2009 CCT membership meeting. CCT also pays \$30 club dues to the SW Region. One of the significant benefits that all NCCC clubs receive is \$1,000,000 of liability insurance coverage for all our events we participate in like the autocrosses, parades, drive-and-eats, car shows, after club social events, holiday party, etc. Since we are referring to parades, I want thank all those who participated in the MATA Parade on McKinney Ave. on Saturday morning, 26 September. The parade was only 10 minutes in length, and the CCT members spent some time visiting all the businesses' promotional booths and collecting giveaways. We then had a very tasty lunch together at D & S Oyster Restaurant on McKinney Ave, which has been in there since 1976.

There are only two more First Choice weekend events remaining this year, which is the OCCC 10 LS autocrosses on October 24 & 25 and Tejas 13 LS autocrosses on October 31 & November 1st.

The SW region is hosting & paying for the hospitality for the November 2009 national meeting in Kansas City. The cost will be less than \$500.

In the SW Region, the first place women's points leader is Bernyce Molenda who is now retired and can devote more time to participating in race events.....until the retirement money runs out. The first place men's points' leader is Johnny Gann (and Ted Molenda is a very close 2nd place). The first place club, which doesn't surprise us, is OCCC. CCT is in 12th place out of 16 clubs in the SW region, which isn't too bad since we are no longer a racing club, and we've settled into being a drive-and-eat and road trip club, and not in a big hurry to get where we are going. We just want to make sure we get there safely, and don't get any traffic speeding tickets.

The SW Region Treasure's report was read and discussed at the governors' meeting, and the balance is very favorable. I will provide a summary of the report at our October 16th CCT membership meeting. The next SW region governors' meeting is October 31st, in conjunction with Tejas' first choice weekend. NCCC rule book is changing again, which seems to change every two years.
