Governor’s Report.

I hope that everyone had a great Christmas holiday, and got everything they wanted, and are still in good health...and able to now pay for all the gifts they bought for family and friends! It was certainly nice to see everyone at the annual holiday party dinner and Chinese gift exchange held at the Texas Motor Speedway Condo Club House. Both the food and company was great! Many thanks to Ronnie Walker for providing the great music again at our annual gathering.

Since we are going into a new year, I thought that it’s time to remind everyone on the NCCC Insurance benefits that is provided to CCT and its club members. The NCCC Insurance Program’s basic policy has a \$1,000,000 limit for all club-sponsored activities, including meetings that we attend, social functions, rallies, autocrosses (Ours is May 22 & 23 at Mineral Wells with Cowtown Vettes, so put the date on your calendar). It also includes gymkhanas, slaloms, time trials and drag events.

The NCCC policy includes these coverages:

- **Spectator Bodily Injury Liability** – Protection for spectator suits.
- **Property Damage Liability**
- **Legal Liability to Participants** – Contingent upon signed wavier & release – protection for participant suits is the part that protects you if an injured participant sues is contingent upon having a signed waiver and release form. For this reason, all participants, officials and casual workers must sign a waiver and release form at each event. (This is why we have everyone sign the wavier at meetings and club sponsored events). By signing, you are covered. If you don’t sign, you are not covered.
- **Errors and Omissions Liability** – (\$1,000,000 Limit) – Indemnification against claim alleging a breach of duty as an event organizer or property owner.
- **Medical Personnel – Additional Insured** – Injury arising out of the rendering of, or failure to render, professional health care services other than emergency medical services
- **Personal Injury Liability** – Coverage for false arrest, malicious prosecution, libel, slander, right of privacy violation, wrongful entry or eviction.
- **Food, Drink, and Concessions Liability** – Example – Food Poisoning
- **Contractual Liability**
- Non- Member and Member Car Owners – Driver and Liability – automatic additional insured up to policy limits.
- **Host Liquor Law Liability** – Injury arising out of the giving or serving of alcoholic beverages at functions incidental to named insured business
- **Broad Form General Liability Endorsement**

Participant Accident Coverage is important coverage that provides protection for all participants, including drivers, navigators, mechanics, official and casual workers. The participant accident coverage covers all participants up to the policy limit. Additional higher limits are available upon request for an additional fee. All accidental death dismemberment and weekly indemnity benefits are primary coverage.
